2010-2011 REGISTRATION AND TUITION AGREEMENT

Terms and Conditions for New 4-year-old Preschool Families

1. *To qualify for in-diocese tuition rates, a signed 2010-2011 Pastoral Recommendation Form must be submitted by February 11, 2010.*
2. *Tuition for the 2010-2011 4-year-old program is \$3,900.00 for in-diocese students and \$4,150.00 for out-of-diocese/non-catholic.*
3. *All registration forms along with a \$250.00 per student non-refundable registration fee are due by 2010-2011. This fee will be applied toward tuition.*
4. *A \$300.00 per student non-refundable admission fee is due by May 3, 2010. This fee will be applied toward tuition.*
5. *The cost of FACTS tuition management service will be borne by the user. Families choosing to pay monthly, quarterly, or semi-annually must use FACTS management service.*
6. *The first tuition payment is due in July 2010.*
7. *In order to guarantee enrollment, all fees and tuition are payable on or before each due date indicated. Students not current with fees and tuition at each due date, including the July 2010 payment, will be placed on the waitlist.*
8. *The signatures of both parents and guardians, if applicable, are required. By signing, the parent(s) or guardian(s) agree to make payments in accordance with the above.*
